I BBA

1. In order to avoid Redundancy of Subject in various disciplines, the following changes, were made in the Subject title :
 - a) Business Communication (1901CC1) changed to Business Correspondence (1901CC1)
 - b) Business Statistics (1901AC1), changed to Fundamentals of Business Statistics (1901AC1)
 - c) Financial Accounting (1902CC3) changed to Introduction to Financial Accounting (1902CC3)
2. Tally 9 - Computer literacy paper is provided to the Students from the academic year 2013 onwards. It carries two Credit. The Syllabus is framed and passed in the present BOS meeting.

II BBA:

1. English will be offered by English Department in the Second year degree course also. Since English is coming into the curriculum in the III Semester, the Financial Services will be taken out in order to accommodate English. So Skill based paper Essentials of Communicative Skills is scrapped and a new paper, Campus to Corporate (1903SB1), will be introduced in the third Semester. In the fourth Semester in order to accommodate English, Services marketing ^(U4.CC12) is taken out of the curriculum. Both these core papers will be offered to the Students (2019 Batch)

in the III year. Strategic Management (U5ME2) and Consumer Behaviour (U6ME4) are taken out to accommodate Financial Services and Services Marketing in the III year for 2019 Batch Students.

2. In order to avoid Redundancy of Subject in various disciplines the following changes, were made in the Subject title:
 - a) Business communication (U3ACK3) changed to Business Correspondence (U3ACK3) offered to B.Com CA department.
 - b) Banking Law and Practice (K3ACU3) changed to Principle & Practice of Banking. It is passed in the BOS of B.Com CA department.
 - c) Human Resource Management (U4CC9) changed to Employee Management (19U4CC8)
 - d) Management Accounting (U4CC11) changed to Management Accounting Theory & Practice (19U4CC10)
3. Value Added crash course: MSME^(19U4CC11) is introduced in the place of Digital Marketing from the academic year 2020-21 onwards.
MSME Syllabus is framed and passed in the BOS meeting. In the Subject Marketing Management (19U3CC6) digital marketing and its characteristics are included in the first unit.
4. The Syllabus for online course - Event Management offered to the entire college Students, from 2014 is approved by the Board.
5. In the Subject Management Information System (19U4ACK4), PIVOT IN EXCEL is included in the first unit.
6. In Management Accounting Theory and Practice Unit V heading is changed to Standard costing and Budgetary control. Meaning of Standard, Standard Costing, Variance are included.

7. In Cost Accounting (1903CC7) Unit 5 Reconciliation of cost and financial accounts be elaborated for the better understanding to Staff and Students.

III BBA

1. Case Analysis (U5CC15 major paper) ^{to be} is offered to the other major interested Students (B.Com CA) to promote academic flexibility in the curriculum.

2. We will be introducing a new Self-Study paper Quantitative Aptitude for third years only (2018 Batch). Course content will be provided and academically bright students alone will study the paper. They will be tested internally and externally and it will be offered as extra credit paper. It carries 2 credits. The course has been approved by the board.

3. In order to avoid Redundancy of Subjects in various disciplines the following changes were made in the Subject title:

Financial Management (U5CC13) changed to Financial Management and Practice (1905CC11)

4. The Elective papers, International Business Management (U5ME1) and Industrial Relations (U6ME5) Syllabi, are elaborated for better understanding of the topics for external examiners and Students. Minor modifications are also to be made in the Subjects.

5. In case analysis (U5CC15), current cases of Industry/Business from newspapers and magazines be included in areas of cases dealt-with.

6. The title of the paper Employability Skills I (U5SB4) and Employability Skills II (U6SB5) is changed as "Employability Skills (U5SB4) and "Competitive Examination Skills (U6SB5)

In Competitive Examination Skills, Unit 5 Interview Skills, Mock Interview and Group Discussion are included.

1. Dynamism which means current affairs on the Subjects will be introduced as VI unit for each paper, first and Second year only. It will be tested in monthly, Weekly or hourly tests (Internal) only. It includes Social Implications also.
