I. Purpose and Scope:

This Memorandum of Understanding (MoU) provides a framework for collaboration between the Department of History, Fatima College and Gandhi Museum, Madurai to explore the scope for skill training programmes for the students and to inculcate Gandhian values in them.

This co-operation and co-ordination is not limited to the parties to this MoU, and each party independently or jointly, may co-operate with other governmental and non-governmental extensions, interested state, regional and local agencies, colleges and universities, private industries, non-profit organizations, and foundations and public interest groups.

Fatima College is an Autonomous Institution and is run by St.Joseph's Society of Madurai (of the congregation of the sisters of St.Joseph of Lyons). The college is functioning with the prime objective of enhancing the quality of life by enabling the women to become contributors in the economic, social, and political development of India by equipping them with multi-dimensional capabilities required for different life situations. The college is given Five Star Status of merit by NAAC in 1999 out of a comprehensive assessment. In 2004 the UGC conferred on the college the status of College with Potential for Excellence. In 2006 and 2013 NAAC re-accredited the college with 'A' grade. The college was ranked 94th in the All India NIRF Ranking in 2019.

The **Department of History** was established in the year 1957 to impart holistic education by giving preference to rural, first generation, economically backward women. The vision of the Department of History is to prepare the students to be the responsible citizens of India, to nurture

the students to become future administrators and to develop independent, critical thinking. The objective of the Department of History is to nurture the students as empowered women, to make them know historical concepts, current issues and technology based strategies and to develop a passion for learning history.

Whereas, Gandhi Memorial museum, established in 1959, is a memorial museum for Gandhi located in the city of Madurai. It is one of the five Gandhi Sanghralayas in the country. It comes under the peace museums worldwide selected by the United Nations Organization (UNO). The palace of Rani Mangammal was renovated and converted into museum. The museum contains 14 original artifacts used by Gandhi, blood stained cloth of Gandhi on the day assassination, 124 rare photographs depicting various phases of Gandhi along with enriched library for research scholars and Khaadi and village industries section.

The vision of Gandhi museum is to preserve, process, promote and share the standard for the betterment of humanity. Their core values are commitment and responsibility, Humility and friendship, scholarship and professionalism. To promote the study diffusion and understanding of Gandiji's life through the establishment of satyagrahalayas, libraries, study archives, Gandhi galleries in public interest and through other media of communication. To train men and women for care others. To publish literature, periodicals, books, thoughts and teachings of Gandhiji in furtherance of the objectives.

II. Authorities:

This MOU is intended to facilitate co-operative efforts for mutual provision of services and support by both parties in the academic programme of the Department of History, Fatima College. The co-operation and co-ordination is not limited to the parties to this MOU, and each party independently or jointly, may co-operate with other governmental and non-governmental extensions, interested states, regional and local agencies, colleges and universities, nonprofit organizations and foundations and public interest groups.

III. Roles and Responsibilities:

- Offer guidance and support to the students to carry out the assignments in areas decided mutually by both the parties.
- Create opportunities for the students to take up their career in development sector by exposing them to the realities at the ground.
- Conduct of joint studies and research in areas of mutual interest.
- Conduct of training programmes to educate the people to know the Gandhian values and entrepreneurship training.
- * Facilitate internship for the students of the Department of History, Fatima College.
- Identifying and documenting practical/ local issues and violations and make them to find solutions.
- Develop and promote a satyagraha and non-violence culture among the students, through workshops, seminars, meetings and other instruments such as publications, posters and street theatres.
- ❖ Facilitate value based Certificate Course on Gandhian Thought.

IV. Finance:

Fatima College and Gandhi Museum, Madurai shall handle their own activities and utilize their own resources, including the expenditure of their funds unless otherwise agreed in specific implementing agreements, in pursuing these objectives. Gandhi Museum, Madurai will not provide financial assistance in any form for the students to take up their internship. The students to manage all the expenses required for completing the assignments including payments for the equipments and infrastructure provided by the centre as decided and fixed mutually by the centre and the college.

V. Rights in Data:

It is the intent of the parties that the information and data exchanged in furtherance of the activities under this agreement will be exchanged without use and disclosure restrictions unless the parties agree to impose restrictions, or specifically designated data (or) information.

VI. Duration:

on 2nd March, 2020

1. Purpose and Scope:

This Memorandum of Understanding (MoU) provides a framework for co-operation between the Department of Sociology & Social Work, Fatima College and Shant Manas, Madurai to explore the application of various skills of the students during the course of their study and to help them to promote positive mental health by working in close partnership with families and the local communities.

Fatima College is an Autonomous Institution and is run by St.Joseph's Society of Madurai (of the congregation of the sisters of St.Joseph of Lyons). The college function with the prime objective of enhancing the quality of life by enabling the women to become contributors in the economic, social, and political development of India by equipping them with multi-dimensional capabilities required for different life situations. The college was given Five Star Status of merit by NAAC in 1999. In 2004 the UGC conferred on the college the Status of College with Potential for Excellence. In 2006 and 2013 NAAC re-accredited the college with 'A' grade. The college was ranked 94th in the All India NIRF Ranking in 2019.

The **Department of Sociology** was started in the year 1960, keeping Women Studies and Social Gerontology as the thrust areas. PG course on Social Work was introduced in the year 2005 with Community Development, Medical & Psychiatric and Human Resource Development as Specialization. The vision of the Department of Sociology& Social Work is to be a *Nucleus for Social Transformation to create a society with equality, justice and peace*. The objective of the Department of Sociology& Social Work is to enable students to analyze the social realities with

sociological perspectives, to motivate the students to imbibe analytical skills and research aptitudes, and to promote social consciousness in students to empower the marginalized.

Shant Manas was begun in 2007 by Dr. Cahn Vasudevan, a retired Consultant Psychiatrist and Psychotherapist from the UK. His was a simple idea of 'putting back' some of his skills and experience into a small rural community of the country of his origin and making mental health services accessible to a section of people who previously had no such service available to them. Shant Manas began as a small clinical project in 4 villages. Since its inception it has expanded its field of care to 14 villages, with a combined estimated population of about 80,000. It is staffed by three full-time mental health social workers (supported by supervision from 2 seasonal psychiatrists) overseeing the psychiatric and social care of 220 service users, with around 50 of them being in active treatment, as of in May 2015. As well as the treatment of psychiatric disorders, Shant Manas aims to provide education on mental health to the local population, reducing stigma and myths surrounding mental health. Due to its success the service continues to expand as demand and awareness of mental health increases. The main body of clinical and social work at Shant Manas is to do with all forms of mental illness and their consequences, but in a very limited sense with difficulties relating to alcohol addiction or learning difficulties.



YUVA: A Youth Development Initiative

This memorandum of understanding is made and entered into on the December 18, 2019 between Confederation of Indian Industry, Young Indians (hereinafter referred as CII-Yi) and Fatima College (Autonomous), Madurai.

WHEREAS

Fatima College (Autonomous) is an educational institution founded by the Sisters of St. Joseph's Society of Madurai of the Congregation of the Sisters of St. Joseph of Lyon, France, which focuses primarily on Women's Empowerment through Education and is affiliated to Madurai Kamaraj University.

Fatima College is a Post Graduate and Research College for women and is a Catholic Minority Institution. It strives to sustain excellence, quality and relevance while equipping the students to meet the demands of Higher

Young Indians (Yi) is an initiative and integral part of the CII formed with an objective of creating a platform for Young Indian's to realize the dream of a developed nation. It has over 2500 direct members in 42 city chapters, and indirect membership of 15000 through its Yuva. "To become the Voice of Young Indian's Globally" being the vision of Yi, it reaches out to the global Indians wherever they are to make them an integral part of the Indian Growth Story.

Through the CII Yi Yuva, Yi intends to provide an opportunity to start thinking and work for India, Sowing the seeds of thinking about India and its growth at schools and colleges, an invaluable motivation for young minds to see how other young achievers are making a difference, bridging potential with achievement, a unique networking opportunity with peers across the country, developing leaders for tomorrow, an experience on leadership and team building and an opportunity to volunteer / participate in Yi events at the chapter and national level.

The role of the institution would be to enroll a minimum of 50 students at the beginning of the year and increase the same substantially through the years that follow; that their contact details will be given on the day of their sign-up; that it undertakes to follow the charter (attached), that it will depute a faculty/ teacher coordinator for the Yi Yuva whose role has been defined in the charter, that the students will be given the motivation and opportunities to engage in activities and initiatives that they conceptualize, that these students are to make reports

Yi may terminate this MoU forthwith in the event of any breach of the terms mentioned in this MoU or in the attachments. This termination will be on mutual basis by either party giving the other a prior written notice of one month in writing.

Each party will be entitled to receive / obligated to pay prorata funds to the other party for the activities mentioned under the MOU upto the date of termination if any agreed upon

MISCELLANEOUS:

The partners or their representatives or the volunteers will not project or represent in any manner CII because this is a voluntary organisation and has nothing to do with the other activities of the CII and its associates. The Memorandum either directly or indirectly will not confer any right on any partner or volunteer to claim any amount from CII either suffered on account of any accident or loss caused because of any activity or on any account.

Both parties hereby agree that the terms and conditions for the above individual activities shall be mutually agreed and reviewed and updated from time to time.

This Agreement will be in force for an initial period of one year and may be extended for further periods before the expiry of this Agreement.

This agreement shall become effective from today, the December 18, 2019 upon signing of this agreement.
