 - (II) **Scope for specialization** in the paper should also be given
- ❖ E-contents in the form of **podcast** may also be prepared and uploaded
 - **Value added Courses**
- ❖ Value added courses such as **TOEFL/IELTS** and Blog writing skill may also be introduced by the Department of English
- ❖ Chemistry department may offer short term course on "Identification of food adulterants".
 - **Seminars, Workshops & Conferences**
- ❖ Programs on language development may be organized
- ❖ Outcome of the program should also be included to evaluate the credibility of the event
 - **Research, Consultancy and Extension**
- ❖ Multiple community engagement programs may be instituted to bridge the gap between the society and students
- ❖ The departments may tie up with international organizations to conduct awareness programs such as "Women mental health in post COVID era" & "Preventing violence against Women in the educated world" etc.
- ❖ **RAC** may take efforts to distinguish the research communication as "Web of science /Scopus/UGC-CARE listed journals.
