MEMORANDUM OF UNDERSTANDING

I. Project Title:

Collaborative programme of training, research and entrepreneurship in food processing and technology.

II. Purpose and Scope:

This Memorandum of Understanding (MoU) provides a framework for co-operation between The Research Centre of Home Science, Fatima College (Autonomous), Madurai and ICAR Krishi Vigyan Kendra, CENDECT, Kamatchipuram, Theni in training, research, internship, information dissemination and exchange of subject experts.

This co-operation and co-ordination is not limited to the parties to this MoU, and each party independently or jointly, may cooperate with other governmental and non-governmental extensions, interested State, Regional and Local Agencies, Colleges and Universities, Private industries, Non-Profit Organizations, and Foundations and Public Interest groups.

The Research Centre of Home Science, Fatima College and ICAR Krishi Vigyan Kendra, CENDECT, Kamatchipuram, Theni shall handle their own activities and utilize their own resources, including the expenditure of their funds unless otherwise agreed in specific implementing agreements, in pursuing these objectives. Each party shall carry out its separate activities, as agreed within the context of this MoU in a coordinated and mutually beneficial manner.

The agreements may provide for the use of faculties, personnel, student training (Internship), extension activities and co-operative projects and shall comply with the laws, regulations and orders pertaining to the respective departments and agencies.

This MoU between the Research Centre of Home Science, Fatima College and ICAR Krishi Vigyan Kendra, CENDECT, Kamatchipuram, Theni is intended to facilitate co-operative efforts for mutual provision of services and support, as well as technical assistance by both parties in the conduct of research and development, transfer, utilization, on-the job training and commercialization programme and activities in public sectors.

III. Responsibilities:

With the context of the purpose and scope above, the Research Centre of Home Science and ICAR Krishi Vigyan Kendra, CENDECT, Kamatchipuram, Theni agrees to use reasonable efforts to fulfill the following:

- Exchange of faculty and students for purposes of research;
- Reciprocal assistance for visiting faculty;
- Coordination of joint research, lectures, and training;
- Development of mutually beneficial research programmes;
- Exchange of documents and research materials in the fields of mutual interest provided that, to the best knowledge of the respective institutions, there is no prohibition at law or otherwise against the exchange.

IV. Rights in Data:

It is the intent of the parties that the information and data exchanged in furtherance of the activities under this agreement will be exchanged without use and disclosure unless the parties agree to impose restrictions on specifically designated data or information.

V. Responsible Officers:

VII. TERMINATION


Either party may terminate this MoU for any reason it deems substantial upon a 90-day written notice to the other party.




