Accordingly, you are required to apply for fellowship not later than three months from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of National Fellowship for Scheduled Caste Students available at https://socialjustice.gov.in/ & https://www.nsfdc.nic.in/

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. Initially, the awardee is to register at Scholar's Corner available at Scholarship & Fellowship Management Portal (SFMP) (https://scholarship.canarabank.in/). The Universities / Institutions will link the data of the awardee with the Master Data on the SFMP with their unique Maker and Checker IDs. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the awardee on monthly basis. Based on the data updated on SFMP by the concerned Universities / Institutions, the payment of the fellowship will be made to the awardee.

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on https://ugcnet.nta.nic.in. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.
