The Intellectual Property Rights Cell organized a Guest lecture on "Intellectual Property Rights" on **8.05.2019**. Mrs. Malarvizhi, Professional Patent Agent was the resource person. Mrs. Malarvizhi discussed the nature of IPR and different methods of IPR like copy right, trademark and graphical indicators. She explained how innovations lead to product development and narrated the Indian Patent law and process involved in patenting. She explained the pipeline of patent filing and processing time duration. She also discussed how the patent should be registered by the individual and the company. The products that cannot be patented in India were also discussed such as farming, animal breeding, food processing, horticulture, mathematical laws, atomic energy, multidisciplinary applications and pharma products. The role of WIPO and Paris Convention Treaty (PCT) were also discussed.

She encouraged the participants to go through the patents available for cycle, safety, pin and tooth pick. Madam outlined the activities to be carried out by the IPR cell. She emphasized the cell should have domain experts and legal experts. Awareness programs are to be conducted to motivate students. The interested students with innovative ideas

can submit their concept to the cell. Experts in the cell can scrutinize and finally can register for patenting.

A few students of Home Science also interacted with the resource person regarding how to patent their food products. All the participants were actively participated and clarified their queries. The session was useful and enriching.
