- ✓ To build in children conscientiousness in doing what is right and boldness to question the wrong.



In the month of August, the Consumer club of our college organized an awareness program about Medical Negligence in the Consumer Protection. The students belonging to Commerce and Economics were divided into 6 different groups and were given 6 different titles related to medical negligence. Students were emphasized to know their basic rights. Many case studies were presented and were discussed among the students. The students participated actively and enthusiastically.

Ms.G.Priyadharshana presented on **“CONSUMER PROTECTION ACT AND MEDICAL PROFESSION”**. She explained that the Consumer Protection Act 1986 in India has opened a new quasi-judicial, cheap and convenient system of Redress for the consumer of goods and services but doesn't include medical services. She also quoted some cases in which the Court has included health services in the definition of service under the Consumer Protection Act.


Ms.SivaRanjani presented few cases on Medical Negligence like,

She stressed that “The Medical Practitioner must bring to his task a reasonable degree of skill and knowledge, and must exercise a reasonable degree of care”. If he fails in his degree of care, he ought to do negligence.

Ms. K. Nandhini, has presented on **“PROOF OF NEGLIGENCE”** under various cases.

Ms. S. Mahalakshmi presented on **“CRIMINAL NEGLIGENCE”**. Here, we learnt about many sections which cover the acts of Medical malpractices. She emphasized that, “According to Section 304 A, whoever causes the death of the person due to negligence is punished with imprisonment for 2 years or fine or
