Fatima College organized a "Stakeholders Meeting" in which the stakeholders from its adopted villages (Kondayampatti, Thirumalnatham, Nedungulam, Vadugapatti, Ambalathadi), recognized under *Unnat Bharat Abhiyan* of The Ministry of Human Resource Development (MHRD), took part to discuss the avenues of development in the villages concerned. The meeting was held at the college premises from 11 a.m. to 1.30. p.m.

- Dr. K. Ravichandran, Zonal Coordinator, *Unnat Bharat Abhiyan* Programme, Gandhigram Rural Institute Deemed University, Gandhigram, was the chief guest of the occasion.
- Dr. Sr. G. Celine Sahaya Mary, Principal, Fatima College and Sr. Arul Vinnarasi, WEAT and ROSA Coordinator graced the occasion. About 35 people from the UBA villages, III UG student representatives and staff members participated in the meeting. 35 people from the villages, students and staff members of Fatima College attended the meeting. The people from the villages shared their experiences with regard to the students' services at their respective villages. After that the chief guest, Dr. K Ravichandran appreciated the services of the students and staff and stated the following:
- He gave an overview of the functioning of the UBA 2.0 and the ways to get funding to develop the village
- He insisted that the students should find scientific solutions for the problems in the villages. He also added that the students should analyze the problems with a research attitude
- He oriented the staff and students about the National Portal and the ways to avail the services given by our Government for UBA 2.0
- He highlighted that there are provisions to start self-employment and incubation centres.
- He added that the students can find new solutions for the problems and get them patented
