A Stamped Receipt for the fellowship amount Rs.12,000/- Rupees Twelve thousand only) obtained from the Research Scholar every month may be retained by the concerned Head of the Department/Institution for record purpose and the stamped receipts for the every quarter may be sent to CICT to make the payment.

If the Ph.D. thesis is submitted in the middle of the fellowship period, it has to be communicated to the Central Institute of Classical Tamil.

Further fellowship amount for the second year will be sent to you after review the performance of the Ph.D. scholar at the end of first year.

The Research Scholar is also eligible for a Contingent grant of Rs.12,000/- (Rupees Twelve thousand only) per annum for meeting the expenditure towards stationery, travel connected with research, purchase of books, xerox, etc. The contingency grant will also be released to the Research Scholar through you at the end of first/second year after submission of original bills along with Stamped Receipt and Statement of Expenditure with duly certified by the Supervisor and forwarded by the competent authority to this office.
