In an organization, the people, processes, and technology must all complement one another to create an effective defence from cyber attacks.

Ransomware : Ransomware is a type of malicious software. It is designed to extort money by blocking access to files or the computer system until the ransom is paid. Paying the ransom does not guarantee that the files will be recovered or the system restored. **Locky , Trolldesh , GlobeImposter, Philadelphia, and Cerber, WannaCry ,NotPetya , Bad RabbitMalware** : Malware is a type of software designed to gain unauthorized access or to cause damage to a computer.

Social engineering: Social engineering is a tactic that adversaries use to trick you into revealing sensitive information. They can solicit a monetary payment or gain access to your confidential data. Social engineering can be combined with any of the threats listed above to make you more likely to click on links, download malware, or trust a malicious source.

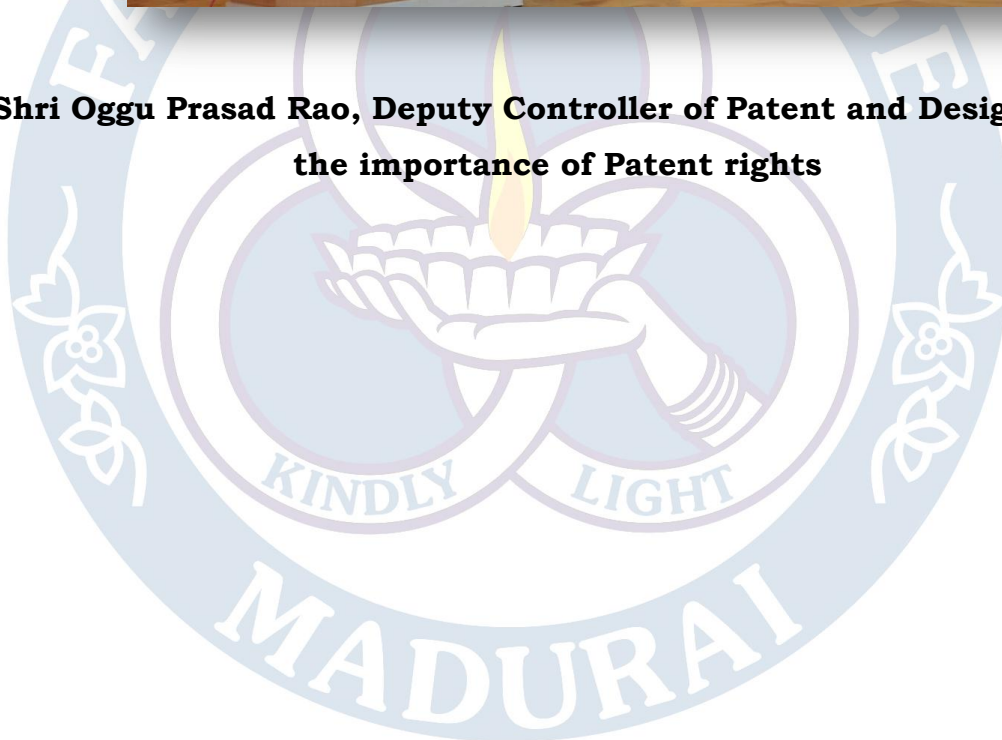

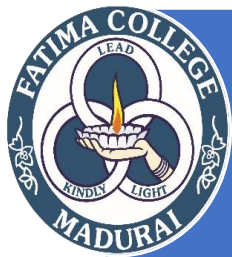

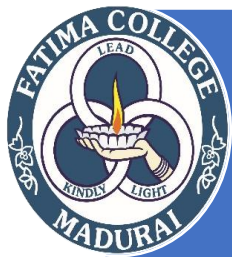

I Year Procedures

- Teaching them to learn to apply the principles of green chemistry at the start of their college science education will allow them more time to firmly establish a foundation in the principles of green chemistry that they can later use in their future careers.

Estimate the amount of Ferrous Ammonium Sulphate (FAS) present in the whole of the given solution. You are provided with a standard solution of Ferrous ammonium sulphate containing 2g in 100ml. The link solution is KMnO_4 .

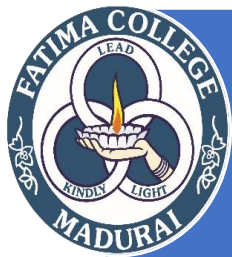

- After they have completed the procedure and analyzed their results, students are challenged in a “Think green inquiry section” to consider what principles of green chemistry are positively impacted and to research particular relevant topics.
